The right candidates with prior sheet metal experience will perform the following responsibilities:

- Operate and set up CNC press brake machines, adjusting for speed, material thickness, and angles based on blueprints or work order specifications.
- Interpret and read blueprints, technical drawings, or computer-generated reports to grasp the metal fabrication specifications and requirements.
- Conduct routine machine maintenance, including calibration and checking of instruments and tools to guarantee optimal operation.
- Adjust machine settings, load programs, and set up tooling for each job.
- Inspect finished workpieces for adherence to specifications using tools like calipers, gauges, and micrometers, and rectify any defects or inconsistencies.
- Choose, position, and secure the correct raw materials and workpieces on the machine.
- Adjust or input machine program parameters as needed, leveraging an understanding of machine operation and material traits.
- Adhere to safety protocols and wear the right personal protective equipment (PPE) to avoid accidents and injuries.

- Identify and resolve issues with press brake machinery, making necessary adjustments or repairs to reduce downtime and adhere to production schedules.
